



Resources for Obtaining Advanced Pharmacology Education Required by HB 216

COA holders who need to obtain advanced pharmacology education required for CNP, CNS and CNM licensure may benefit from this list of education providers who reported to the Board that they provide the online advanced pharmacology education necessary under HB 216. Appropriate courses offered by other institutions, companies, or organizations would also be acceptable. Courses must meet the specified requirements for content, including a minimum of 45 contact hours and coverage of required Ohio/Schedule II content. COA holders are encouraged to confirm with the course provider that the courses meet these requirements or if additional coursework may be necessary.

Renewal Reminder – Important 2017 Deadlines

Renew your **RN license** no later than **October 31, 2017**

You must renew your RN license to be eligible to complete the 2017 COA renewal/APRN license issuance process

Complete the 2017 COA renewal/APRN license issuance process
at the same time you renew your RN license,
but no later than **December 31, 2017**

APRNs who successfully complete both processes in 2017 will transition to licensure
