Advisory Committee on Advanced Practice Registered Nursing Summary Information – Applications and Appointments May 2019 Additional Vacancy and Extended Deadline Date¹

Section 4723.493, Ohio Revised Code, establishes the Advisory Committee on Advanced Practice Registered Nursing (APRN Advisory Committee) to advise the Board on the practice and regulation of APRNs and make recommendations to the Committee on Prescriptive Governance.

The open positions are for two-year terms, unless otherwise specified, effective upon appointment by the Board at the May 22-23 Board meeting. Recommendations for appointments may be submitted to the Board from organizations representing APRNs practicing in Ohio and from schools of advanced practice registered nursing for APRN faculty applicants.

Open Positions

1. One CRNA actively engaged in practice in Ohio in a clinical setting
2. One APRN actively engaged in practice in Ohio in a clinical setting
3. One APRN who serves as a faculty member of an approved program of nursing education that prepares students for licensure as APRNs
4. One representative of an entity that employs ten or more APRNs actively engaged in practice in Ohio
5. One CNM actively engaged in practice in Ohio in a clinical setting (**this position became vacant on April 18, 2019; the position will be filled to complete the term that ends July 2020**).

Applying for the APRN Advisory Committee

The application is posted on the Board website at www.nursing.ohio.gov.

Please submit the completed application directly to the Board of Nursing, as specified below, no later than 5:00 p.m. on Thursday, May 13, 2019. If you already submitted an application earlier in April of 2019, you do not need to re-submit a new one.

Applicants should include a recommendation on the letterhead of either an organization representing APRNs practicing in this state or from a school of advanced practice registered nursing for APRN Faculty applicants. Applicants should also include a resume or curriculum vitae.

Meetings

This Advisory Committee generally meets 3-4 times a year at the Board office in Columbus. Those appointed in May would attend the remaining of the 2019 scheduled meetings, June 17 and October 28 (10:00 a.m. to 3:00 p.m.). Committee members serve without compensation, but members may receive payment for their actual and necessary expenses incurred in the performance of their official duties.
